Inclement Weather Policy - 2020

Moana Kindergarten will promote a safe environment for children, staff and parents.

Rationale

At Moana Kindergarten inclement weather is likely to be extreme heat, storm, or wind.

Implementation

The following guidelines are in place:

- Site leader or nominated supervisor for the site is to monitor daily weather forecasts (eg Bureau of Meteorology) and identify any potential inclement weather risks.

Heat

- Hats will be worn outside between 1st August and 30th April as per site's Sun Smart Policy and Procedure.
- Sunscreen is applied in the middle of the day 1st August to 30th April as per the site's Sun Smart Policy and Procedure.
- Drinking water will be provided and staff will endeavour to ensure all children have water in their drinking bottles.
- Staff will promote and encourage the drinking of water, especially on hot days.
- Outdoor activities will be restricted to shaded areas and physical exertion and rigorous exercise will be restricted.
- Cooling water play activities will be provided.
- Cool restful periods will be scheduled and promoted throughout the day.
- Bushfire action plan will be in place and actioned if required.

Wind, Storm or Hail

- At times of extreme wind children will be restricted to engaging in activities in the enclosed veranda or inside the main building.
- During storms (including dust or electrical) or hail children will be restricted to using the area in the enclosed veranda (if appropriate) and inside the main building.
- The doors to the outdoor learning environment will be closed if required due to a threat to children's safety.

Rain and cold weather

- Protective clothing, such as raincoats and rubber boots are to be worn when it is raining.

- Families will be encouraged to provide weather appropriate clothing for children so that they can access the outdoor play space year round (weather permitting).
- Families are encouraged to pack change of clothes.

During and following a period of inclement weather the nominated supervisor is to:

- Consider the health and safety risks to employees, children/young people before allowing them to undertake outdoor activities.
- Look out for tree debris such as leaves, nuts and branches that might pose a slip or trip hazard; damaged tree limbs and branches that may fall; and wet floors, equipment and stairs.
- Monitor severe weather danger warnings.
